We want to maintain our companies in the long term by continuously fulfilling the fair profit expectation of the shareholders. The essential prerequisites for this are the long-term satisfaction of our customers and our workforce, the health and safety of all persons working in the company, efficient and sustainably effective corporate processes, and the appropriate consideration of the concerns of all other interested parties.

This policy documents our attitude to economically and ecologically responsible management while providing secure jobs. We are convinced that quality, environmental and climate protection, occupational health and safety as well as energy efficiency complement each other positively in the business activities of our companies and will give them equal priority in our corporate decisions.

The manufacture of our products by melting, casting and rolling processes is energyintensive due to the nature of the process. Even with the current state of the art, these are associated with residual safety and environmental risks as well as the not inconsiderable use of natural resources, some of which are fossil fuels.

The inner-city location of our site also requires greater consideration for our neighbours.

Mitigating global climate change also requires our contribution through local action at all levels of business. We will assess our processes in terms of their carbon footprint and identify our carbon avoidance potential.

This will lead to the establishment of a programme to transform our processes towards carbon neutrality.

- set a science-based climate target to reduce our CO₂ emissions according to the rules of the Science-Based Targets Initiative (SBTi)

- Pursuit of the zero defect principle (minimum defect costs) and the philosophy of a "zero accident" company

 - Innovation in process and product development
 - Continuous improvement of energy and resource efficiency
- Implementation of a roadmap regarding the transformation of our own processes as well as along the supply chain to achieve carbon neutrality of our products
- Preventing work-related illnesses and maintaining and improving the health of the workforce
- Reduction of the environmental impact in terms of air pollutant and noise emissions
- Expansion of the criteria for the selection of suppliers for the procurement of products and services with regard to environmental impact, climate neutrality and compliance with due diligence obligations along the supply chain
